# Official Rules

**1. HOW TO ENTER: NO PURCHASE NECESSARY.** To enter, complete official entry form/ release, film and edit a short video, and submit your entry form and release, and video to the Rome Snowboard Design Syndicate at:

- a. Local GNAR Film Contest, Rome SDS, 1 Derby Lane, Waterbury, VT 05676, USA
- b. All entries must be submitted in Quicktime format (.mov or .mp4) on a Thumb Drive, or Flash Drive (returnable upon request)
- c. All entries must be no longer than five (5) minutes in length

**ALL ENTRIES MUST BE RECEIVED BY SPONSOR BY MAY 15, 2012.** No illegible, incomplete, forged or altered entries will be accepted. Sponsor and judges not responsible for late, lost, stolen, damaged, incomplete, misaddressed, or misdirected entries or mail. All entries (including videos) become the exclusive property of Sponsor and will not be returned to entrants.

**2. SELECTION OF WINNERS:** The Videos will be watched by a group of the athletes and employees of the Sponsor. This group of people will select the winners based on overall impression of the Videos. Prize winners will be notified by mail and e-mail. Winners will be required to sign an affidavit of eligibility and liability/publicity release. Prize may be awarded to alternate winner if affidavit is not returned within 14 days after mailing to winner or if prize notification letter is returned as undeliverable. If Prize is won by a minor, it may be awarded in the name of a parent or legal guardian.
